- ***SALARY SLIP*** FOR SALARIED PERSON AND DECLARATION OF INCOME ON LETTER HEAD FOR BUSINESSMAN WILL BE USED AS PROOF OF INCOME
- CUSTOMER WILL RECEIVE CREDENTIAL EMAIL IN REAL TIME AND ***OTP SMS*** ON MOBILE IN 48 HOURS


